

## **Angel Hugger Agreement**

I,	, the client, of

have read, understand and agree to all of	the following terms	and conditions set forth
by <b>3 Minute Angels</b> , the supplier:		

- 1. That the Client is booking this service for the Client and Client alone;
- 2. Each session will be conducted in private. It is not a spectator sport and will not be conducted in the presence of other people;
- 3. There will be no video recording or digital recording of this session by either party;
- 4. The Client will provide photo identification (License or Passport) when booking the appointment and understand this will be cross-checked by the Angel-hugger prior to commencement of the service;
- 5. The services will be a pre-paid and there is a 100% cancellation fee that effectively means no refunds if the Client cancels the service within 24 hours prior to commencement of services;
- 6. The Client can reschedule a session outside 24 hours prior to commencement of service.
- 7. No sexual activity is permitted. No kissing allowed. If the Client try to force themselves sexually onto an Angel-hugger, the Angel has the right to stop the session and leave;
- 8. Both parties will remain clothed the entire session. If either party needs to change clothing, this will be done in private and out of sight of the other party. If I show off areas normally covered by undergarments purposely, the Angel has the right to leave. If I have a clothing request that is season appropriate, I can raise a request (example: an Angel being asked to wear a red sweater in winter instead of a blue long sleeve shirt);
- 9. No touching in areas covered by undergarments is permitted. If this occurs, the Angel has the right to leave;
- 10. Phone contact between Angel-hugger and Client is not allowed;
- 11. All appointments must go through the Supplier. For every new session, a call or e-mail must be made informing the Supplier;
- 12. The Supplier knows all appointment dates, times, and locations. Angels will check in after appointments to confirm they left safely;
- 13. The Angel will not break any federal, city, state or county laws, statutes or regulations while performing services with the Client;
- 14. The Client will not break any federal, city, state or county laws, statutes or regulations while with the Angel;
- 15. If an Angel's safety is at risk, an Angel may carry a non-lethal personal defense item to defend themselves;
- 16. Payment for each session is due before the session. Payments are accepted through credit card and bank transfers of trading as a Minute Angels.



- 17. If the Client cancel or a session is cut short for any reason, the Supplier will not provide refunds;
- 18. If the Client cancel within 2 hours prior to a session or don't show up, then no refund will be provided by the Supplier;
- 19. Cleanliness and adequate hygiene is required by both parties. This specifically includes showering or teeth brushed within 12 hours of the appointment, wearing freshly laundered clothing, and no (or minimal) perfume/cologne be worn by both parties unless requested;
- 20. I agree to hereby indemnify and hold harmless the Supplier from any and all claims by the Client which may arise out of and in the course of the service. The Client releases the Supplier from any physical or financial liability;
- 21. No specific information regarding the Client will ever be shared with another party outside of what is outlined in this agreement unless I, as the Client, give written or e-mail permission for a specific purpose.
